Analytical Summary

The The total estimated value of mineral production (excluding atomic minerals) at ₹ 2,82,966 crore during 2015-16 decreased by 2.6% as compared to the previous year. Mineral production was reported from 31 states, union territories and off-shore regions during the year, of which the bulk value of mineral production of about 91% was confined to thirteen states (including Off-shore regions). Off-shore regions accounted for 19% in the value of national mineral output, followed by Rajasthan (12%), Odisha (9%) and Chhattisgarh, Jharkhand and Telangana (7% each). Remaining States/Union Territories contributed rest of the value during the year under review.

State-wise analysis revealed significant increase in the value of mineral production in Meghalaya, Goa, Tripura, Madhya Pradesh, Telangana, Himachal Pradesh and Jammu & Kashmir. The states reporting significant decrease in value of mineral production were Assam, Jharkhand, West Bengal, Odisha, Chhattisgarh, Karnataka and Arunachal Pradesh (Tables- 1 & 2).

The index of mineral production (excluding atomic minerals) (with base year 2004-05=100) for 2015-16 at 129.3 displayed a growth of 2.2% as compared to the previous year.

The total number of reporting mines (excluding atomic minerals, petroleum (crude), natural gas and minor minerals) at all India level was 2,054 in 2015-16 as against 3,635 in the previous year (the difference is mainly due to declaration of some minerals as minor (vide Gazette Notification dated 10.2.2015). Out of the 2,054 reporting mines 274 were located in Madhya Pradesh followed by Tamil Nadu (252), Gujarat (225), Jharkhand (199), Odisha (159), Chhattisgarh (157), Karnataka (146), Andhra Pradesh (135), Maharashtra (128), Telangana (82), Goa (77) and Rajasthan and West Bengal (76 each). Remaining mines were reported from other states (Table- 3).

Mineral - wise reserves/resources in the country as on 01.4.2015 are furnished in Table - 4.

The present status of each mineral-based industry as mentioned in the tables of respective State reviews is, however, not available.
