Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 [MCDR (Amendment), 2021] in respect of your Sunkeri Lime shell Mine (ML No.2462), over 122.63 Ha. (Lessee-M/s Coastal Minerals) in Uttar Kannada Dist. Of Karnataka State

Sir.

The following provisions of Mineral Conservation and Development Rules'2017 [MCDR (Amendment), 2021] were found violated in your above said mine during inspection on 26.10.2021 by the undersigned in the presence of yours representative Mr. Rafiq and Mr. Manjunath K. Bhat, Technical Qualified Person of your mine.

Rule No.	Nature of Violation observed
28	A notice of temporary discontinuance of work in mines ought to be submitted to this
(1)	office (RCOM, IBM, Goa Region), when the mining operations in the mine or part
	thereof are discontinued for a period exceeding ninety days.
	Mining operations in your mine reported to be discontinued since long,
	reportedly from year 2016-17. However, notice of temporary discontinuance of work
	in mine has not been submitted by you so far to this office. Moreover, you have been
	directed by this office letter of even No., dated 29.05.2019 to submit the notice of
	temporary discontinuance of work in mine immediately. In spite of that the same has
	not been submitted by you so far.
	A monthly Return in respect of a Mining Lease/Mine ought to be submitted to this
45 (5) (b)	office (RCOM, IBM, Goa Region) before the tenth day of every month in respect of the
	preceding month in electronic form along with a signed print copy of the same if it is
	not digitally signed.
	However, Monthly Returns have not been submitted by you since April'2018
	in respect of your above said Mining Lease/Mine.

An Annual Return in respect of a Mining Lease/Mine ought to be submitted to this office (RCOM, IBM, Goa Region) before the 1st day of July each year for the preceding financial year in electronic form along with a signed print copy of the same if it is not digitally signed.

However, Annual Returns for the years 2018-19, 2019-20 & 2020-21 have not been submitted by you so far in respect of your above said Mining Lease/Mine. Moreover, you have been directed by this office vide letter No. – 6(2)2012-GOA-Part file/V-III, dated -03.04.2019 to submit the Annual Returns online from 2013-14 onward. In spite of that Annual Returns have not been submitted by you online.

- **02.** In this connection, it is brought to your notice that the above violations constitute an offence punishable with fine under Rule 62 of MCDR (Amendment), 2021.
- **03.** Action according to Rule 45(7) of MCDR (Amendment), 2021 can be initiated, if compliance of Rule 45 is not found satisfactory.
- **04.** You are advised to rectify the above violations **immediately** and intimate the position to this office **within 45 (forty-five) days** from the date of issue of this letter.
