## Sub.: Order of suspension of mining operations under Rule 11(2) of Mineral Conservation and Development Rules, 2017 in respect of your "KORI" Limestone mine (area 11.57 Hects.) in Ramgarh district, Jharkhand State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine as per office record and communicated to you vide this office Regd. A/D letter of even no. dated 03.05.2018 in the form of violation letter giving you 45 (forty five) days for rectification of the same, followed by a show cause notice issued vide this office Regd. A/D letter of even no. dated 04.10.2018 giving you a period of 30 (thirty) days for rectification of the same.

### Rule No.Nature of violation observed in detail

**Rule-27(2):**Where financial assurance is required to be furnished by the holder of the mining lease under sub-rule (1), such amount of financial assurance shall be submitted to the authorised officer, as the case may be, in the form of a bank guarantee in the format specified by the Indian Bureau of Mines:

Provided that where financial assurance has already been furnished before the commencement of these rules, an amount equal to the difference between the financial assurance due as on the date of notification of these rules and the financial assurance already furnished, shall be furnished to the authorized officer, as the case may be, within a period of ninety days from the date of notification of these rules.

In your case, it has been observed that no such difference amount of Financial Assurance has been submitted to this office as per statute.

- **02**. It has been found that you have not rectified the violation even after lapse of thirty (30) days from the date of issue of show cause notice and the violation of above rule still stands violated.
- **03**. The non-compliance of the Rule 27(2) of MCDR, 2017 defeats the very purpose of the nature of violation. Therefore, by virtue of powers upon me under Rule 11(2) of MCDR, 2017, I hereby order suspension of all mining operations in Kori Limestone mine (area 11.57 Hects.) in Ramgarh district, Jharkhand State.

**04**. This order shall remain in force until revoked in writing. After compliance of the provisions of aforementioned Rules of MCDR, 2017, you may apply to this office for revocation of this order.
