Violation of provisions of MCDR, 2017 in respect of your "Karampada Iron ore Mines" in Sub: West Singhbhum District of Jharkhand State.

Based on the office records the following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine.

Nature of violations observed in details.

Rule- 45(5): The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller or any other authorised official of the Indian Bureau of Mines in the following manner, namely:-.

(c): an annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form

In your case Annual Return for the year 2017- 18 has not been filled online till date.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule-62 of MCDR-2017. The relevant extract of the rule 62 is given below:
- "62 Penalty: Whoever contravenes any of the provisions of these rules shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to five lakh rupees, or with both, and in the case of a continuing contravention, with additional fine which may extend to fifty thousand rupees for every day during which such contravention continues after conviction for the first such contravention.
- 03. You are, therefore, advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
