The following provisions of MCDR, 2017 were found violated in your above mine during inspection on 11/01/2018 by the undersigned in presence of Shri. M.C.Hembram, Senior Inspector of Mines, O/o Dy. Director of Mines, Koira Circle and mine officials Shri K Mahanta, VP Geology and Shri A.K.Patra, Mines Manager.

Mining Operation have not been carried out in accordance with the Scheme of Mining (SOM) approved vide Letter No. MSM/FM/08/BHU/2016-17 dated 03.11.2016 to the extent indicated below.

02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
