Sub: Violation of provisions of MCDR, 2017 in respect of your Tiringpahar Manganese Mine over an area of 643.612 hectare in Keonjhar district of Odisha.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 10.01.2018 by the undersigned accompanied by Yourself, S/Shri Niranjan Kumar, Mine Manager, and Naga Raju Vengalaraj, Geologist of your mine.

Rule No.	Proposed in the approved mining plan / Rule	Violation
11 (1)	As per the approved mining scheme dated 29/04/2015, i) It is proposed to construct 575 m of retaining wall and garland drain around the dumps of Guruda – Block A&B. It is also proposed to stabilize the inactive dump slopes of dumps in Guruda-A&B by planation, covering an area of 5.457 Ha during 2016-17.	i) During inspection it is reported that 315 m of retaining wall & garland drain with stabilization of inactive dump slopes of dump (Guruda Block-A) covering 3.6 ha is only carried out. No protective measures were taken regarding dump of Guruda Block-B.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Besides, inability to comply with the provision of Rule 11 (1) is liable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty-five) days** from the date of issue of this letter.
