The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during the inspection on 21/08/2014 by Sri.N.Subrahmanyam Assistant Mining Engineer of Indian Bureau of Mines, Chennai.

RULE No	NATURE OF VIOLATION				
22(1)	The Owner, agent, mining engineer or manager of every mine shall send to the Controller General, Controller of mines and Regional Controller of Mines, Indian Bureau of Mines, Chennai intimation in "Form C" of the opening of a mine so as to reach them within fifteen days of such opening. But mining operations was commenced on November 2012, so far no Form – C is received.				
45(5)(a)	The Owner, Agent, Mining Engineer or Manager of every mine shall submit monthly return of the mine before 10 th of every month in respect of preceding month in the form F-8. But the party has not submitted the same to the Regional Controller of Mines, Indian Bureau of Mines, Chennai, since inception of mine.				
45(5)(b)	The Owner, Agent, Mining Engineer or Manager of every mine should submit an annual return of the mine before the 1 st July every year for the preceding financial year in form H-8. But the party has not submitted the same to the Regional Controller of Mines, Indian Bureau of Mines, and Chennai for the year 2013-14.				

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of Mineral Conservation and Development Rules 1988.
- 03. You are advised to rectify the above said violation immediately and intimate the position to the office within 45(fourty five) days from the date of issue of this letter.
