Subject: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Balaghat Manganese Ore Mine, (182.3004 Hect.) Mine code 40MPR01002 in Balaghat district of M.P. State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during inspection on 27/12/2022 by the undersigned in presence of Shri Rajesh Bhattacharya, Jt. GM (Mines), & Shri Nilesh Khedekar, Mine Manager:

Rule 11 (1)	According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. The Modification of Mining Plan of afore mentioned mine was approved vide this office letter No-MP/BALAGHAT/MANGANESE/RMP-47/2017-18 dated 23.05.2017 incorporating the proposals of working from 2017-18 to 2021-22. During the inspection following provisions of the rule are found violated against the approved proposals for the year 2021-22:
	 Only 853 meters horizontal development is done against the proposal of 1270 meters. 330440 metric Tons of ROM is raised against the proposal of 668566 metric tons. This clearly indicates the lagging in development as well as ROM production.

- 3. Working of 13.5 level towards South side has gone beyond lease boundary after 48 cross cut encroaching the 7.5 meter barrier and entered in to adjoining Balaghat & Awlajhari Mine (76.409 hect.).
- 4. Black dump (partly) & Slag is dumped outside the lease area.
- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.
- 03. Non-compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining operations under the provisions of rule 11(2) of MCDR-2017.
- You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
