विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Banour Limestone Mine, Mining Lease over an area of 0.874 ha located near Village: Banour Tehsil: Paonta Sahib, District-Sirmour, H.P State.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 02.11.2020 in the presence of Shri Ajay Purkayastha, Mine Manger.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operation were not carried out in accordance with the approved Review & Updation of mining plan with PMCP vide letter no 614(2)/MS-B-190/11- DDN dated 18.07.2016 to the following extert: (i) As per proposal during the year 2018-19, it was proposed to 15 plantations in barren area within lease, but plantation was not carried out as per proposal.
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least on hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. Review of Mining plan with PMCP was approved vide letter no. 614(2)/MS-B-190/11-DDN dated 18-07-2016 but lessee has not submitted the Review & Updation of Mining Plan with PMCP till date.
33	The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rule for the year 2019-20
35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per the notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self assessment report before the 1st day of July every year for the previous financial year, along with the soft copy (in standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31st day of march for that financial year, covering the mining lease and an area of two kilometers from the lease boundary, to the Regional Controller or the authorized of the Indian Bureau of Mines. Whereas holder of the mining lease has not submitted by the online self assessment report and the satellite images as per rules for year 2019-20.
45(7)	The holder of a mining lease has submitted incomplete or wrong information in Annual Return 1. Part-3 Consumption of material – Reported Diesel consumption during year 2019-20 is 0 which is not correct. 2. Ex mine Price is not correct in annual return of year 2019-20
55	Every holder of mining lease shall employ a geologist in the mine. But geologist has not been appointed in the mine.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operation can be suspended as per rule 11(2) in case of non-compliance of any Rule/sub-rule of 11 of MCDR 2017.
- Advise the State Government to order suspension of all mining operation in the mine as per provision of Rule 45(7), in case incomplete or wrong or false information has been furnished in statutory returns or fails to submit statutory returns under rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
