Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your Periyagalur Limestone mine over 2.80hect in Periyagalur village of Ariyalur Taluk & District of Tamilnadu state.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017,(Amended as on 03.11.2021) is found violated in your above mine during the inspection on 17/10/2022 by the undersigned in the presence of Mr M.Manoharan,Agent (Mines)& Mr E.Ganesan,Dy Manager &QP:

Rule No	Nature of Violation
34A(2)	The Georeferenced Ortho-rectified Multispectral satellite images of the lease area has not been submitted to the Controller General and Regional Controller of Mines till date which should have been submitted on or before 1st day of July 2022 in the standards formats such as GeoTIFF along with metadata or any other format as may be specified by the Indian Bureau of Mines .

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

62. Penalty: Any contravention of rule 34A(2) shall be punishable with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
