The following provisions of Mineral Conservation and Development Rules, 2017(MCDR,2017) were found violated in your above mine during the Review of Mining Plan inspection on 18.12.2018 by Smt. Ch.Suseela, AMG in the presence of Sri P.R. Mishra, Qualified person and Shri. Kailash, Lessee's representative.

Rule No	Nature of Violation
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5.
	Mining operations are not being carried out in accordance with the proposals given in approved Mining Plan vide letter No. AP/KNL/MP/Fe-15/HYD dated 06.04.2015 to the extent indicated below:
	(i) The waste dumps are encroached 7.5m safety barrier zone between Boundary Pillar No.13 to 14 and Boundary Pillar No. 15 to 17 without having any such approved proposals.
55(1)	Every holder of a mining lease shall employ, in case of category A mines, a whole time
(3)(iii)	Mining Engineer and a Geologist having minimum of five years of professional experience of working in a supervisory capacity in the field of mining. However a Mining Engineer and a Geologist has not been employed so far in your mine.

- 02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017.
- O3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
