Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Injepalli Limestone (ML.NO. 2417) over an extent of 897.86 Ha Area in Gulbarga-Dist of Karnataka State

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 was found violated during inspection of your above mine on 9/8/2017 by the undersigned in presence of Shri Ravindra Lagwankar, Mines Manager & other mine officials.

| 11 (1) | <p>The mining operations are not being carried out as per the approved Scheme of Mining No-KNT/GLB/MS/Lst-180-SZ, dated 1/1/2013 to the extent as mentioned below.</p> <p>During year 2016-17, 5,334,549 tonnes of limestone were produced against the proposed 11,040,000 thereby resulted in (-) 52% deviation in production of Limestone. Further, during year 2016-17, 313,700 tonnes top-soil wastes generated against the proposed 223,120 tonnes (139,450 m³), thereby resulted in (+) 41% deviation. This may lead to deviation in ROM to waste ratio of 1:0.058 against proposals of 1:0.02.</p> |

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2) of MCDR 2017, if compliance of rule 11(1) is not found satisfactory.

04. You are advised to **rectify the above violation immediately** and **intimate the position to this office within 45 (forty five) days** from the date of issue of this letter.
