Subject: Violation of provisions of MCDR 2017 in respect of your Karadikolla Suresh Iron Ore Mine, ML No 2502, Area- 42.10Hect. (as per CEC Sketch) in Bellary District of Karnataka state.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 08.08.2017 by undersigned in presence of S/Shri Y.V.R. Krishna Reddy - Mines Manager and J. Vijay Narasihulu – Mining Engineer.

Rules	Nature of Violations observed
11(1)	As per the Modified Scheme of Mining , approved by IBM vide letter no. 279/25/89/BNG dated 26/08/2015, for the period of 2015-16 to 2017-18:
	Exploration by 5 nos. of core boreholes were proposed during F.Y. 2016-17, against which no exploration was carried out by the lessee during said period and till the date of inspection.
45 (5) (c)	During site inspection it was found that incidental 'low grade material' /mineral rejects were being blended with high grade iron ore within the working pit before final stacking, but the quantity of mineral reject was not mentioned in the Annual Return of 2016-17.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
