Subject: Violation of provisions of MCDR 2017 in respect of your Karya Magnesite Ore Mine, ML No 2495, Area- 86.25 Hect. in Karya Village, Nanjungod Taluk, Mysuru District of Karnataka state.

Sir,

The following provision of the Mineral Conservation and Development Rules, 2017 was found violated in your above mine during inspection on 06.11.2017 by undersigned in presence of S/Shri H J Basavarajappa- Mines Manager and Chandrasekhar – Geologist.

Rule	Nature of Violations observed
11(1)	<p>As per the Scheme of Mining, approved by IBM vide letter no. KNT/MYS/MS/Mg-218-SZ dated 06/12/2013, for the period of 2013-14 to 2017-18:</p> <p><i>Exploration by 5 nos. of boreholes was proposed during F.Y. 2016-17, against which no exploration was carried out by the lessee during said period.</i></p> <p><i>Also, exploration programme by 26 nos. of boreholes has been proposed by the lessee during five years scheme period, from 2013-14 to 2017-18; against which no borehole is actually drilled so far.</i></p>

02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty Five) days** from the date of issue of this letter.
