Subject: Violation of provisions of MCDR 2017 in respect of your S M Block Iron Ore Mine, ML No 2505, Area- 40.47 Hect. (As per the lease deed) in Narayanapur village, Sandur Taluk, Bellary District of Karnataka State.

Sir,

The following provision of the Mineral Conservation and Development Rules, 2017 is found violated in your above mine during inspection on 12.01.2018 by undersigned in presence of Shri M.S. Devaraj Setty - Mines Manager and other mining officials:

	As per the Scheme of Mining, approved by IBM vide letter no. 279/119/89/BNG dated
11(1)	03/03/2016, for the period of 2016-17 to 2020-21:
	230 meters of retaining wall and 550meters of garland drains are proposed as a part of
	dump protective measures during F.Y. 2016-17.
	During site inspection it is observed that only 80m of retaining wall and 270m of garland
	drain is constructed by the lessee so far.
35(2)	The copy of high resolution satellite image obtained from CARTOSAT-2 satellite LISS-IV sensor
	on the scale of cadastral map as on 31/03/2017 covering the mining lease and an area of two
	kms from the lease boundary has not been submitted so far.

- 02. It is brought to your notice that violation of the above Rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty Five) days** from the date of issue of this letter.
