#### **CHAPTER NO.1: GENERAL INFORMATION:**

- 1. At para 1.1: The lease code and Mine code of the lease area are not mentioned. The same should be mentioned.
- 2. Para 1.2: The details regarding list of mining leases held by already held by the applicant / applied area should be indicated.
- 3. At Para 1.3.6: The PAN of Owner is not mentioned. The same should be furnished.
- 4. Instead of leaving blank any Column /Row, NA or any information may be given appropriately.

# **CHAPTER NO.2: GEOLOGY AND EXPLORATION**

- 5. Para 2.2.1.5: The details of existing pit along with lithologs to be mentioned.
- 6. At para 2.2.2.10: The details of chemical analysis are to be furnished properly.
- 7. At para 2.2.2.14: Area Covered under Exploration: All the required information under this column is not furnished. The same should be furnished. Further, please mention the year i.e. 2021-22, 2022-23 instead of year 1, year 2 etc.
- 8. At para 2.2.4.2: The Method used for resource estimation is not mentioned correctly. The same should be corrected.
- 9. At para 2.2.6.5.1: It is mentioned that for the year 2021-22, 04 number of bore holes have been drilled, but the details are not attached /enclosed. The same may be furnished along with enclosure / annexure.

#### **CHAPTER 4: MINING OPERATIONS**

- 10. At para 4.2.1.2, The details of existing dumps are mentioned. But during the site inspection, there is no dumps observed in the lease area. Please clarify.
- 11. At para, 4.2.2.2: Year wise Development is mentioned 1 year, 2 year instead of 2021-22, 2022-23. The same should be corrected accordingly.
- 12. Para 4.2.2.2: Ore to OB ratio is not calculated. The same should be furnished.
- 13. At para, 4.3: The details of Material Handling Summary is not furnished. The same should be furnished and annexures also be enclosed with serial numbering order.

## CHAPTER 6: PROGRESSIVE MINE CLOSURE PLAN:

14. At para 6.1: The Mined out area in the lease is not mentioned. The same may be furnished.

- 15. At para 6.2.3.2: The year wise proposal for green belt is mentioned, but the proposed location is not mentioned. The same should be furnished.
- At para 6.2.4.1: The details of cumulative work done (upto end of previous block of five years) are not given. The same should be given.
  CHAPTER 7: FINANCIAL ASSURANCE/ PERFORMANCE SURETY (AREA PUT TO USE).
- 17. The area put to use to be verified, accordingly the bank guarantee details to be furnished properly.

## CHAPTER 8: REVIEW OF PREVIOUS PROPOSALS

- 18. At para 8.1.1: The total area at the beginning of the proposal period is not furnished. The same may be furnished.
- 19. All the details under Review of previous proposals and achievements are not furnished. The same should be furnished at relevant columns.

#### **ANNEXURE**

20. Annexure numbers not mentioned. All the annexures must be numbered and enclosed serially.

# PLANS / PLATES AND SECTIONS

- 21. Highest and lowest RL of topography may be verified.
- 22. GCP details are not furnished. The same may be furnished.
- 23. Proposal period may be furnished in the title box in all the Plans and sections.
- 24. The relevant Plans and sections should be signed with date by certified surveyor, qualified person, mines manager, mining engineer, and Geologist as per provision of Rule 34 of MCDR 2017.
- 25. Wind direction may be shown in wind rose diagram at the top right of the relevant plans. Further, colour code given for different features in plans and sections to be same.
- 26. Production & Development section- Individual Year wise section may be prepared and furnished separately for each year.
- 27. The Financial assurance table should be given in plate and all the area shown in the table should be clearly demarcated on plate and indexed.
- 28. All the plans and section should be signed by the Lessee.
