The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 03.11.2017 by the undersigned in presence of Sh. Deepak Gorasia, Mining Engineer:

Rule No.	Nature of violation observed in detail
Rule 26 (2)	A yearly report to be submitted before 1 st July of every year setting forth the extent of protective and rehabilitation works carried out as envisaged in the approved mine closure plan has not been submitted to this office for the year 2016-17.
Rule 28(2)	Notice of temporary discontinuance of work in mines in Form E has not been submitted.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
