	& Pit No. 1 of Block III between grid 200N to 500N & 5900E to 6100E have been
	carried out which was not proposed in approved mining plan while development is less
	in Pit No.2 of Block II (Refer Plate III A).
	2) As per para 8.3.5 total plantation druing the year 2016-17 was proposed on 7.57 hect. area
	while actual plantaion has been carried out on 4.6 hect. area.
Rule 19(1)	Log book of heavy earth moving machineries have not been maintained.
Rule 26 (2)	A yearly report to be submitted before 1 st July of every year setting forth the extent of protective
	and rehabilitation works carried out as envisaged in the approved mine closure plan has not been
	submitted to this office for the year 2016-17.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operation can be suspended under rule 11(2) of MCDR, 2017 if compliance of rule 11(1) of MCDR 2017 is not found satisfactory.
- O4. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
