- 02. You are advised to attend these deficiencies as per the annexure and resubmit the document, complete in all respects, in three bound copies along with soft copy in the form of CD (4Nos.). In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put to use for Mining and allied activities @ Rs.Five lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.
- 03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

SCRUTINY COMMENTS IN RESPECT OF KOLIMIGUNDLA LIMESTONE MINE OF M/S SRI SAINATH MINERALS OVER AN EXTENT OF 4.048 HA IN SY.NOS 195/4A2A, 195/4A2B AND 195/4A3A OF KOLIMIGUNDLA VILLAGE AND MANDAL, KURNOOL DISTRICT.

GENERAL

- 1. Para 1.1.2, as the lease is expiring on 22.8.2022, present status of lease as per section 8A of MMDR Act 1957 needs to be submitted. An affidavit is also to be submitted in this regard.
- 2. In Para 1.3.4.1, status of Environmental Clearance needs to be submitted.
- 3. In Para 1.3.4.4, total area acquired needs to be furnished.

Geology & Exploration:

- 4. In Page No.18 and 23, it is mentioned that Category -I "Float and Placer Deposits" which is incorrect. Needs to be corrected wherever it is applicable. Method of mining mentioned as "Other than fully mechanized", to be changed as "Mechanized category A". (Refer Rule 55 (2) of MCDR,2017)
- 5. In Para 2.2.4.7, Cost & Revenue Factors, total capital investment furnished is incorrect and entire calculation is to be reconciled accordingly.
- 6. For Reserve Estimation, the bulk density considered is 2.25, which is on lower side than the bulk density considered in this Region i.e., 2.5 t/cu.m.
- 7. In Para 2.2.4.7, Reserves table, the quantity of total mineral resources furnished is incorrect, which needs to be corrected.

Mining:

- 8. In table 4.2.2.2, Year wise opencast development, location of advancement is not matching with the relevant plans. Please correct it.
- 9. In table 4.6.7, No. of Persons engaged per day, the figures furnished under "Total No. of Persons per day" is incorrect. Needs to be corrected.

Progressive Mine Closure Plan:

- 1. Proposals of protective measures like fencing of Pit, Garland Drain shall be submitted.
- 2. The Form J submitted in respect of 3 DTH drilled in the year 2022 was not signed by a Geologist under whose supervision the exploration activity has been carried out.
- 3. Financial Assurance should be submitted in the form of Bank Guarantee for the area put to use for mining and allied activities as per the Financial Assurance table.
- 4. The final soft copy should be submitted in excel format only.

Review of Previous Proposals:

In table 8.1.1: Lease area utilization, the figures furnished against mining and plantation are not in consonance with that of earlier proposals made in the last approved document.

Annexure

- 1. Annexure-XX: Copy of Approval letter of first Mining Plan needs to be submitted instead of copy of the first Page of the Approved Mining Plan.
- 2. Color photographs should be enclosed as Annexure for easy reference pertaining to Lease Boundary Pillars, Working Pits, Core logs, Afforestation, Ground Control Points.
- 3. The final document shall adhere to the conditions stipulated in CCOM circular 1/2021 & FAQ on format of Mining Plan issued vide CCOM circular no.1/2021 dated 08.09.2021.

Plates

- 1. In all the plans, proposed five year block period needs to be furnished. ML boundary is shown as QL boundary in the index in all the plates. Please correct it.
- 2. In Surface Plan, the surveyor signature is missing. Surface plan is to be signed by the surveyor having certificate of competency of Survey from DGMS.
- 3. In Geological plan, structural features like strike, dip have not been marked. The 3 DTH drilled in 2022 are to be renamed as DTH 5,6 & 7 to avoid the repetition of the numbers.
- 4. In Geological sections, UNFC codes are to be marked instead of G1. The nomenclature of DTH drilled in 2022 are not matching with that of Form-J enclosed as Annexure XII.
- 5. In year wise Production and Development Plans, the location of the proposed area to be developed is not matching with that of Co-Ordinates mentioned in the table 4.2.2.2. Moreover, in the Production and Development Plan for the year 2022-23, proposed index is given for the year 2021-22 and the same mistake is repeated for the remaining 4 year plans, which needs to be corrected.
- 6. Year wise Production and Development Sections are to be reviewed as per the comment at S.No.5 above and the title of the sections are to be corrected.
- 7. In progressive Mine Closure Plan, the financial assurance table is to be pasted for easy reference
