विषय/Sub : Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Raja Krishna Devaraya Iron Ore Mine (ML-2584) over an area of 31.00 Ha located in Kallahalli Village, Hospete Taluk ,Bellary District of Karnataka State.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned along with AME Shiva Kumar in presence of Shri. Sandeep M Naik, Manager Mining, Shri. Manohar, Mining Engineer and Shri. Sudarshan B Wagmare, Geologist on 24.12.2020

Rule	Nature of violations observed
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. Till date no Review & updation of mining plan has been submitted to this office.
24	The holder of a mining lease shall submit a final mine closure plan to the competent authority for approval two years prior to the proposed closure of the mine.  Since the mine is expiring on 22.05.2021, till date no final mine closure plan has been submitted to this office for approval.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
