विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your S.M.Block Iron Ore Mine, (ML-2505) over an area of 40.47 Ha located in Narayanapur Village, Sandur Taluk ,Bellary District of Karnataka State.

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned along with AME Shri Shiva Kumar in presence of Shri. K. Venkatasreedhar, Manager Mining, Shri. M.V.Mahesh, Mining Engineer and Shri. C.Nagabushana, Geologist on 23.12.2020

Rule	Nature of violations observed
11(1)	Modified RMP including PMCP was approved vide letter no. 279/119/89/BNG dated 20/01/2021 for a period of 2020-21. The deviation observed in mining operation vis-a-vis approved document are given below
	The bench height & bench width of 10 mts were proposed respectively. During inspection it was observed that the benches were formed of height more than 10-12 mts in the eastern pit.
45(7)	As per part V, section 4 of the Annual Returns submitted for FY 2019-20; 5, 55,030 Tones of mineral reject had been generated with grade of 15 to 25% Fe. On field inspection no such quantity was observed to be stocked/used in the mines. Moreover the same quantity has been shown as Backfilled as a part of Overburden disposed.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017. Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
