H M Shiv Kumar-Assistant Mining Engineer in presence of Sri Pompapati G - Manager Mining, Shri. Shivaputra - Mining Engineer on 19.11.2020

Rule	Nature of violations observed
11(1)	 Scheme of Mining was approved vide letter no. 279/372/93/BNG dated 29.03. 2016 for a period of 2016-17 to 2020-21. The deviation observed in mining operation vis-a-vis approved document are given below It was observed that 11,594 Tons of excavated ROM was stocked over the proposed excavation area of N 1675277-1675406 & E 656253-656396 causing hindrance for the movement of benches & production.
45 (7)	As per part VII in the cost of production table, DMF & NMET details have not been furnished.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
