The following provisions of the Mineral Conservation & Development Rules 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri. Vikram Singh, Manager Mining, Shri. B N Prasadrao, Mining Engineer and Shri. Jagadish K Madival, Geologist on 10.12.2020

Rule	Nature of violations observed
11(1)	Modified RMP including PMCP was approved vide letter no. 279/116/89/BNG dated 09.09.2020 for a period of 2020-21 to 2022-23.The deviation observed in mining operation vis-a-vis approved document are given below During the year 2019-20, only 6, 44,333 Tons of overburden was handled against the proposal of 7,15,034 tons.

13(1)	In open cast workings, the benches formed shall be so arranged that the benches in ore or mineral and overburden are separate so as to avoid mixing of waste with the ore or minerals. It was observed that the advancement of OB bench in between section line 11-11' to 12, 12' in the western side of the nit was not carried out, thereby, mixing of the
	13-13' in the western side of the pit was not carried out, thereby mixing of the waste/OB bench with limestone bench

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.Further, the violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
