Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during inspection of the mine on 08.09.2021 by the undersigned accompanied by your good self and communicated to you on 18.10.2021 by giving forty five (45) days time for rectification of the same..

11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5
	Mining operations are not being carried out in accordance with the proposals given in approved Mining Plan vide letter no. AP/KNL/MP/LsT-134/Hyd. dated 30.10.2018 to the extent indicated below:
	 It was approved to carry out mining operation by manual method by maintaining bench height of 1.5 meters; but mining operations are being carried out by mechanized method by deploying 0.7 cum Back Hoe excavator by maintaining bench height of 3 meters. It was approved to carry out exploration by 4 no. of trial pits for the year 2019-20 and 4 bore holes for the year 2020-21; against which no exploration was carried out.

03. In this connection, neither you have replied to the violation letter nor shown any interest for compliance of the same.

04. It is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1), 35(2) and 45(7) of MCDR, 2017 is also liable for suspension of mining operations under rule 11(2), 35(4) and 45(7) of MCDR, 2017

05. You are, therefore, directed to show cause within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under Rule 11(2) and 45(7) of MCDR, 2017.

06. Please note that no further notice will be give to you in this regard.
