Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 17.09.2021 by Sri A V Ramesh Kumar, Assistant Mining Geologist of this office accompanied by Sri T.Mallikarjun Reddy, Mines Manager and communicated to you vide this office letter of even no. dated 06.09.2021 giving 45(fort-five) days time for rectification of the same.

Rule No-	Nature of violation
31(1)	Every plan or section prepared or submitted in accordance with the provisions of the MCDR,2017. “In the surface Plan all the features have not been marked. An updated Surface Plan to be submitted.”
40	Every holder of prospecting licence or a mining lease shall take all possible measure to keep air pollution due to fines, dust, smoke or gaseous emissions during prospecting, mining, beneficiation or metallurgical operations and related activities within permissible limits. “ During the inspection of the Mines it was observed that no measures for dust suppression were undertaken”.

02. In this connection, it is to inform that even after a lapse of even after lapse of Forty-five(45) days, no compliance was reported. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under Rule 11(2) of MCDR,2017.

03. Please note that no further notice will be given to you in this regard.
