RAMESH, LESSEE'S REPRESENTATIVE.

CHAPTER NO.1: GENERAL INFORMATION

1. Para 1.2: Khasara Number is to be furnished. The list of mining leases held by M/s BALAJI ELECTRO SMELTERS should be indicated.
2. At para 1.3.1: The approval of earlier Mining Plan & its subsequent review may be given in chronological order, also correct date/ year of period of proposals may be given.
3. At para, 1.3.4.1: The validity column is kept blank, it needs to be duly filled in.
4. Digital signature of Qualified Person should be incorporated on 1st & last page of text.
5. Para 1.3.4.4: Total area acquired/purchased so far is not mentioned, the same may be mentioned with all required details
6. Kml files in respect of boundary pillars, land put to use and proposal should be submitted separately.
7. Instead of leaving blank any Column /Row, NA or any information may be given appropriately.

CHAPTER NO.2: GEOLOGY AND EXPLORATION

8. At para 2.14.6: The nature / Form of Mineral shall be correctly.
9. Para 2.2.1.5: The details of existing pits are to be mentioned.
10. At Para 2.2.1.14: The details pertains to area proved as non-mineralized. The details of exploration carried out in that area to be enclosed.
11. At para 2.2.4.2 & 2.2.4.12: The depth of the area is not mentioned while calculating the resources and reserves respectively. The same may be furnished.
12. At para 2.2.6.5.1: It is proposed 6 nos. of for boreholes for the year 2022-23 and 06 nos. of boreholes for the year 2023-24 in the forest area. Since the mining lease area is in non forest area, accordingly, the details should be corrected and furnished.

CHAPTER 4: MINING OPERATIONS

13. At para 4.2.1.2, the location of the existing dumps should be mentioned clearly.
14. At para 4.3.3, the details pertains to proposed dump handling quantity (t), proposed recovery of saleable Mineral (t), proposed waste quantity (t), grade range (%) have not been furnished. The same may be furnished.

CHAPTER 6: PROGRESSIVE MINE CLOSURE PLAN:

15. At para 6.2.3.2: The year wise proposal for green belt is mentioned, but the location is not mentioned. The same should be furnished.

CHAPTER 7: FINANCIAL ASSURANCE/ PERFORMANCE SURETY (AREA PUT TO USE).

16. All the details of bank guarantee is not furnished at relevant column. The same should be furnished.

CHAPTER 8: REVIEW OF PREVIOUS PROPOSALS

17. At para 8.1.1, the total area at the beginning of the proposal period, the total area proposed under activity and the total actual area utilized in the proposal period not mentioned properly. The same may be furnished properly with correct details.
18. All the details under review of previous proposals and achievements are not furnished. The same should be furnished at relevant columns.
19. At para 8.2.6.1: The proposed quantity mentioned in review chapter are not correct. The same should be rectified.

CHAPTER 9: IMPACT ASSESSMENT

20. At para 9.3.2.1: The table given for present status of the lease area, is not filled at the required columns / furnished. The same should be furnished properly in the table.
21. At para 9.3.3.2: The air quality details for base line Information / present status are not mentioned, the same should be furnished.
22. At para, 9.3.7: All the the details under Socio –Economic Environment are not furnished. The same should be furnished.

ENCLOSURES:

23. Log sheet in the form of Form J, should be enclosed for the drilled boreholes.

PLANS / PLATES AND SECTIONS

24. The Environmental Plan is not legible. The same Plan should be corrected and submitted.
25. During the inspection it was observed that the 7.5 m barrier zone was breached. The suitable reclamation measures to be proposed.
26. The Manganese band is shown in working plan, but the same is not reflected in geological plan. The same may be clarified.
27. The relevant Plans and sections should be signed with date by certified surveyor, qualified person, mines manager, mining engineer, and Geologist as per provision of Rule 34 of MCDR 2017.

28. Production & Development section- Individual year wise section may be prepared and furnished separately for each year.
29. The Financial assurance table should be given in plate and all the area shown in the table should be clearly demarcated on plate and indexed.
30. Name of the mine, lessee and proposed plan period may be furnished in title box.
31. The nomenclature of features in digital information of plates i.e. KML / SHP should be correlated with the hard copies of the plates.
32. All the plans and section should be signed by the Lessee.
