The following provisions of the Mineral Conservation and Development Rules, 2017, were found violated in your above mine during the inspection on 27/07/2021 by the undersigned in the presence of Mr. S.Ramesh DGM (Mines)& Mr G.Balu AGM (Mines) and communicated to you vide violation letter of even no. dated.06.08.2021 giving you a period of 45 days for rectification of the same. :

11(1)	Mining operations have not been carried out in accordance with the Approved Scheme of Mining approved vide Letter No. TN/ALR/LST/MS-1338.MDS dated 22.3.2016 to the extent indicated below: (i) There was a proposal to backfill an extent of 0.75hect in pit no.2 in the year 2020-21, against
	the approved proposal only in 0.10hect has been backfilled during the said year.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017. The reply submitted vide your letter no.ICL/ADL/MINES/D597/21 dated. 07.9.2021 is not found satisfactory and consider as partially complied.

03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.

04. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.

05. Please note that no further notice will be given to you in this regard.
