Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Gumgaon Manganese Ore Mine over an area of 48.596 Hect & 39.97 Hect (Minecode-40MSH14006) situated in District-Nagpur of Maharashtra state.

Sir,

The following provisions of Mineral Conservation Development Rules, 2017 are found violated in respect of your above referred mine during the inspection on 02.08.2021 carried out by the undersigned in presence of Shri. R.U. Singh, Agent & Shri. R.A. Khan, Mine Manager w.r.t. disposal of Stoping permission filed in this office vide letter dated 10.07.2021:-

Rule	Nature of Violation observed
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016. Review of Mining Plan was approved from this office vide letter No. NAG/Mn/MPLN-256/NGP-2017 dated 20.08.2017 for lease area 48.596 Hect. & Modified Mining Plan approved NAG/Mn/MPLN-493/NGP-2018 dated 03.08.2018 for 35.97 hect.
	Area for the proposal period 2017-18 to 2021-22, however on examination the records, it is observed that, there is deviation from the proposals which is as under-
	Stoping operation has been proposed in -300 level between Ch 36.30 to 38.50 (1730 D to 1790 D) whereas in approved RMP no working was proposed in such area for 48.596 hect area lease for the year 2021-22.
	Thus the stoping proposal submitted to COM(CZ) Office is not in commensuration with approved plans mentioned above. Thus there is violation of Rule and non compliance of violation may lead to suspension of mining operation.

2. In this connection, it is brought to your notice that, the above violations constitute an offence punishable under rule 62 of Mineral Conservation and Development Rules, 2017.

3. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
