The following provisions of Mineral Conservation and Development Rules, 2017 (as amended up to 2021) were found violated in the above mine during the inspection on 04/01/2023 by the undersigned in presence of the mine officials Shri B.U.V.N. Raju, Agent and Shri K.K.K.Singh, Mine Manager.

Rule No.	Proposed in the approved mining plan / Rule	Violation
31 (4)	The plans and sections required under these rules shall be maintained up to date with in three months in case of category 'A' mines.	During inspection it is observed that surface plan was not updated within three months. The last updated plan was till 30.06.2022.
34(A)	Every lessee having (a) an annual excavation plan of one million tonne or more in a particular year; or (b) leased area of fifty hectare or more, shall carry out a drone survey of the leased area and upto hundred metres outside the lease boundary in the month of April or May every year and submit the processed output [digital elevation model (DEM) and Orthomosaic] images obtained from such survey or any other format as may be specified by the Indian Bureau of Mines in this regard to the Controller General on or before 1st day of July every year.	Survey has not been carried out and also the related data has not also been submitted to this office.

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence punishable under Rule 62(1) of MCDR, 2017.
