Subject: Violation of provisions of MCDR, 2017, in respect of your Dillai Parbat Limestone Mine (38ASM06001) over an area of 171.00 Ha. in Dillai Parbat Village, Taluka Bokajan, Karbi Anglong district of Assam State.

Sir,

The following provision of MCDR 2017 was found violated in your above mine during the inspection carried out on 11th December 2020 by the undersigned in presence of your mine officials Shri D.Samadar (Mine Manager) & Shri A.K. Uranw & S. Bhattacharya (Mining Engineer).

Rule Number	Nature of violations observed
11(1): No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of the minerals specified in Part B of the First Schedule to the Act where the Grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Mineral Concession Rules, 2016.	Configuration, pattern, height & width of proposed development benches are not as per the proposal given in approved development plans and sections. Systematic development of both ore and waste benches has not been carried out as per the approved review of mining plan document.
55(1)(c): For the purpose of carrying out carrying out reconnaissance, prospecting or mining operations in accordance with these rules:- (c) Every holder of a mining lease shall employ, in case of – (1) Category 'A' mines, a whole-time mining engineer and a geologist. (2) Category 'B' mines a part time mining engineer and a part time geologist.	You have not appointed a full time geologist for carrying mining operations in accordance with the rules.

- 02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are therefore advised to rectify the violation immediately and intimate the position to this office within a period of 45 (Forty Five) days from the date of issue of this letter.
