**Sub. :** Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your **Bhatia Kala Limestone Mine (107.785 Ha), Mine code-38MPR35294 at Village - Bhatia Kala, Distt- Satna (M.P)..**


Sir,

Following provisions of MCDR 2017 were found violated in your above mine during the inspection by the Undersigned on **29/07/2022** in your presence and Shri Sunil Kumar Soni (Qualified person) & mines officials:

Rule No	Nature of violation observed in detail
11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government. <ul style="list-style-type: none"><li>No Core-Boreholes were drilled against the proposal of 30 nos of core-boreholes during the year 2021-22.</li><li>Only 60926 tonnes of ROM is produced against the proposal of 150000 tonnes for the year 2021-22.</li><li>Only 11911 m<sup>3</sup> of OB/waste is generated against the proposal of 94156 m<sup>3</sup> during the year 2021-22.</li><li>Only 15000 m<sup>3</sup> of topsoil is generated against the proposal of 27160 m<sup>3</sup> during the year 2021-22.</li></ul>


- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
