विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your **Injepalli Limestone & Shale Mine (ML No. 2475/ 2417)** over an area of **897.86 Ha** in Injepalli village, Sedam Taluk, Kalaburagi District, Karnataka state (**Mine Code 38KAR10003**).

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H.M.Shivakumar-Assistant Mining Engineer in presence of Shri. Ravindra Lagwankar, Mine Agent and Shri. Shiojee Roy, Mines Manager on **27/12/2022**.

Rule	Nature of violations observed
Rule 45(7)	(i) As part -II A (1) Capital Structure: 1 (ii). : Under value of Fixed Assets, depreciation of Land value of Rs. 1,24,67,000/- during the year reported is not understood. Generally land values do not depreciate. Cost of Production under Part-VII may have to be revised if this is accounted for. (ii) As per part VII: Cost of Production: As per part VII of the Annual Returns submitted, DMF & NMET paid details have not been furnished and accounted for arriving at the cost of Production.

02. The Mining operations and dispatches may be suspended and any action under sub rule (7) of Rule 45 of MCDR, 2017 read with MCDR (Amendment) Rules, 2021.
03. The fine may be imposed for submitting incomplete/ wrong/ false information in Annual Return as per Schedule-II of MCDR (Amendment) Rules, 2021.
04. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017 read with MCDR (Amendment) Rule, 2021.
