The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 were found violated in your above mine during inspection on 18.01.2023 by undersigned in presence of Shri J. Srikanth, Mine Manager & Mining Engineer, Shri Rashmi Ranjan Sahu, Geologist and other mining officials:

45 (7)	a) Part-I: The land use (area in ha) as given in Part-I (12) under 12(ii), i.e., Covered under current(O/C) workings,12(iv) i.e.,Used for waste disposal,12(v) i.e., Occupied by plant, buildings, residential, welfare buildings & roads& 12(vi) i.e., other purpose have not been reported correctly in accordance with approved land use pattern of the last approved RMP dated 03/01/2022.
	b) <u>Part-III</u> : The details of Royalty paid have not been reported in Part-III(2)(a). The DMF and NMET amount has not been reported correctly in Part-III (5)(c).

- c) Part-V: The drill machine details have not been provided in Sec.5 of Part-V.
- 02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021may be initiated.
- 03. The fine may also be imposed for submitting incomplete/ wrong/ false information in annual return, as per Schedule-II of MCDR (Amendment) Rules, 2021
- 04. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 05. You are, therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under sub rule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
- 06. You are herewith given 30 days-time for reply and rectification of the violation from the date of issue of this notice. Please note that no further notice will be given to you in this regard.
