विषय/Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your **Donimalai Iron ore Mine (ML No. 2526)** over an area of **52.82 Ha** (as per CEC & as per lease deed) in Donimalai Block, Taranagar village, Sandur Taluk, Ballari District, Karnataka state. (**Mine Code 30KAR03113**).

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by Sri. H.M.Shivakumar-Assistant Mining Engineer under field guidance by the undersigned in presence of Sri. VuppuLowa Raju, MinesManager and Sri Manohar Mallikarjuna K-Mining Engineer on 27/08/2022.

11 (1)	<p>The Mining operations are required to be carried out in accordance with the approved Review and Updation of Mining Plan document vide letter no. 279/591/97/BNG dated 24/11/2020, However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows:</p> <p>(i) For the Year 2021-22 -Production and development was proposed in the grid points N-1668444-1668803 & E-0672015-0672187 (in North Pit) and N-1667910-1668341 & E-0672201-0672539 (in South Pit)with proposed production of 4,10,000 tonnes of Iron Ore and 2,16,641 tonnes of waste generation, however it is observed that production & development has been carried out in locations N-1668737-1668482 & E-0672063-0672146 (in North pit) and N-1668310-1668000 & E-067306-0672484 (in South Pit). It is reported to have produced only 2,77,000 tonnes of Iron Ore and 70,158 tonnes of waste generation i.e. only about 68% & 32% of total proposed production and development is achieved there by lacking in proposed Development and Bench advancement not achieving the proposed stripping ratio.</p>
