विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your **Jaisinghpur Iron Ore Mine (ML No. 2545)** over an extent of **34.14 Ha** in Jaisinghpur village, Sandur Taluk, Ballari District, Karnataka state.

महोदय/Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 16.09.2022 by the undersigned along with Shri. Gangadhar Bhakat, AME in the presence of Sri. Lakshmikant, Naveen Raju, Manager(HRD), Shri Tejas K, Geologists and other mine officials.

Rule	Nature of violations observed
34(A) (2)	As per sub rule (2) of Rule 34A of Mineral Conservation & Development Rules, 2017, Every lessee, shall submit soft copy of high resolution Georeferenced Ortho-rectified Multispectral satellite images of the leased area and upto hundred metres outside the lease boundary taken in the month of April to June of every year on or before 1 st July of every year, as per SOP in the form of pen drive or hard disc. However, lessee has not submitted satellite data (Cartosat image) as per SOP for the year 2021-22.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

03. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
