Subject: Violation of provisions of MCDR 2017 in respect of your **Karigala** Kyanite mine (ML No.2286) over an extent of 12.14 Ha having Mine code 33KAR14004, in Karigala Village, H.D.Kote Taluk Mysuru District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 19.10.2022 by the undersigned along with Shri Gangadhar Bhakat, Asst. Mining Engineer in the presence of Sri Shivayogi S. S, GPA Holder, Shri Bhaktavatsalam, Mining Engineer.

Rules	Nature of Violations observed
11 (1)	The Review and updation of Mining plan was approved by IBM vide letter no. 279/635/99/BNG dated 12/03/2020 for the period 2020-21 to 2024-25. The deviations observed in mining operation vis-à-vis approved document are given below: i)It was observed during the site inspection, no exploration has been carried out against the proposed 4 trenches having dimension of 10m x 2m x 3m during the year 2021-22. ii) It was observed during site inspection that against the proposed production of 26879 tonnes, the actual production is reported as 4650 tonnes during the year 2021-22. The deviation is 83% less production iii)The construction of Garland drain of 272m and Safety Bund of 272m has been proposed during the year 2021-22. The same has not been carried out so far.

26(2)	The holder of mining lease shall submit a yearly report on protective measures including reclamation and rehabilitation before 1 st July of every year. However, the same has not been submitted for the year 2021-22.
34A	As per sub rule (2) of Rule 34A of Mineral Conservation & Development Rules, 2017, Every lessee, shall submit soft copy of high resolution Georeferenced Orthorectified Multispectral satellite images of the leased area and upto hundred metres outside the lease boundary taken in the month of April to June of every year on or before 1 st July of every year, as per SOP in the form of pen drive or hard disc. However, lessee has not submitted satellite data (Cartosat image) as per SOP for the year 2021-22.
35(2)	As per the rule, every holder of a mining lease shall monitor his mining and allied activities as per the template of star rating in the format and shall submit online its self-assessment report before the 1 st day of July every year for the previous financial year. The same has been submitted on 06.08.2022 after due date. Hence, the lessee shall liable to pay an amount of ten thousand rupees per day for such delay to the Indian Bureau of Mines under Sub-rule (4B) of Rule 35 of MCDR, 2017.
46	The holder of the mining lease shall submit notice of appointment of Agent, Mining Engineer, Geologist under sub-rule (1) of rule 55 in Form-H within fifteen days from the date of such appointment. The same has not been submitted.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
