विषय/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your **Kallur Limestone Mine (ML No. 2648)** over an area of **422.94 Ha** in Kallur village, Chincholi Taluk, Kalaburagi District, Karnataka state (**Mine Code 38KAR10016**).

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H.M.Shivakumar-Assistant Mining Engineer in presence of Sri. V.Balasubramani, Mines Manager and Sri. V.Rami Reddy, Mining Engineer on **30/12/2022**.

Rule	Nature of violations observed
11 (1)	<p>The Mining operations are required to be carried out in accordance with the Approved Modifications to RUMP document vide letter no. 279/1044/2009/BNG dated 04/02/2021, however during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows:</p> <p>(i) For the Year 2021-22, it was proposed to produce 40,00,000 Tons of Limestone. However only 31,49,255 Tones of limestone Production with (-) 22 % Production Limestone is achieved thereby deviating from the proposed quantities. Further, it is also observed that bench advancements are lagging but as per the Annual returns submitted for the year 2021-22 development work is carried out in excess of the approved quantity, is not convincing.</p>

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017 read with MCD (Amendment) Rule, 2021.

03. The violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
