- 04. For Rule 34(A), you are advised to rectify the Digital Aerial Images as per SOP and re-submit the data to this office and also to Chief Mining Geologist, Indian Bureau of Mines, Nagpur within 45 (forty Five) days from the date of issue of this letter.
- 05. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
