The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 were found violated in your above mine during inspection on 19.01.2023by undersigned presence of ShriH.J. Basavarajappa, Mine Manager, ShriY.M. Thriyabmaka Shastry Surveyor, and other mining officials:

	maintained have not shown the respective proposal of approved mining plan as per the		
	provision of this rule.

34A.(1)	The processed output [digital elevation model (DEM) and Orthomosaic] have not been

	rule 34A of MCDR, 2017 for carrying out drone survey and submission of Digital Aerial		
	Images of Mining areas.		
	i)TheDTMresolution is provided in arc degrees units. The resolution unit to be provide		
	in cm as per the SOP (15 cm or better for DTM). Also, the 100 m buffer shp. file of the mine lease boundary not created.		
	ii)The GCPs have not been established/maintained in the mine as per SOP. The details		
	of GCPs have also not been provided in Deg min Sec.		
	iii)The shp files under map of the mining lease area for afforestation, Reclaimed &		
	Rehabilitated area within the lease have not been prepared as per format for SOP. The nomenclature has also not been prepared/maintained as per the approved plan.		
	iv)The co-ordinates of the boundary pillars as provided in Deg min Sec are not		
	matching with the boundary pillar co-ordinates of the ongoing approved mine plan		
	document/DGPS plan. The nomenclature of the boundary pillars is not provided in shp.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
