Subject: Violation of provisions of MCDR 2017 read with MCDR(Amendment), 2021 in respect of your Sankalapuram Iron ore mine (ML No. 2682) over an extent of 111.09Ha located in Sankalapuram Village, Vijayanagara District of Karnataka State

महोदय/Sir,

The following provisions of the Mining Conservation and Development Rules, 2017 read with Mining Conservation and Development (Amendment) Rules, 2021 were found violated in your mine during the inspection carried out on 15/12/2022 by undersigned alongwith Shri H.M. Shivakumar, AME in presence of Shri Lakshminarayana, Senior General Manager, Shri Gopal Joshi, Mine Manager and other mine officials:

Rules	Nature of Violations observed
45(7)	In the Annual Return submitted for the year 2021-22, following discrepancies were observed In Part-III (4) Depreciation on fixed assets given is not tallying with the Deprecation amount given at Part-IIA Capital Structure, same need to be verified and modified. Also, in Part – VII Depreciation amount considered for Cost of Production to be accordingly modified.

- 02. The mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 04. You are therefore directed to show cause within a period of **thirty** (30) **days** from the date of issue of this notice, as to why action under subrue (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.

05. You are advised to rectify the above violations immediately and intimate the position to this office within 30 (thirty) days from the date of issue of this notice.
