Sub: Violation of provisions of Mineral Conservation and Development Rules,2017 in respect of your Mattapalli Limestone Mine (38APR14025) over an area of 46.356 Ha in Mattapalli Village, Mattampalli Mandal, Suryapet district, Telangana.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 09.02.2021 in the presence of Sri.G.S. Subba Rao, DGM(Mines) and Sri. Mahipal Reddy, Manager(Mines).

Rule No.	Nature of Violations observed
11 (1)	<p>No holder of a mining lease shall commence or carry out mining Operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines.</p> <p>Your Review of Mining Plan document was approved vide letter No. AP/NLG/MP/LST-44/HYD dated 21/12/2017 and following deviations have been observed:</p> <p>i. It was proposed to carry out exploration in the plan period i.e., 04 boreholes in 2018-19, whereas during inspection it was observed that no exploration has been carried out as per proposal.</p> <p>ii. There was no proposal for stacking of minerals, whereas during inspection it was found that limestone mineral has been stacked at various places in the working pit which is not in the interest of systematic and scientific mining.</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
