Violation of provisions of MCDR 2017 in respect of your Rajapur Iron ore Mine, ML 2514 over an extent of 24.82 ha(as per lease dead) in Rajapur Village, Sandur Taluk, Bellari District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 21.10.2021 by Sri Arun Kumar, Dy.Controller of Mines along with Shri K. Srinivas, AMG which was communicated to you vide this office letter of even number dated 9/11/2021 giving you a period of 45(Forty Five) days time for rectification of the same.

Rules	Nature of Violations observed
24	During the site inspection in connection with submission of draft Review and updation of mining plan, the following rules have been violated. The holder of a mining lease shall submit a final mine closure plan to the competent authority for approval two years prior to the proposed closure of the mine. The same has not yet been submitted.
26(2)	The holder of a mining lease shall submit to the competent authority a yearly report as per the prescribed format before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan. The same has not been submitted.

28	The holder of a mining lease shall send to the authorized officer a notice in Form- E when the mining operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. The mine was not working for long time. No such discontinuance in Form-E notice has been submitted.
45(5)(b)	Monthly Returns from the month of July, 2021 to September, 2021 have not been submitted.
45(5)(c)	An annual return for the year 2020-21 shall be submitted before 1 st day of July, 2021. The same has not been submitted.

- 02. However, it has been found that no reply has been received in this office. Thus, you have not complied the above pointed out violation till date and in this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017. Further, it is brought to your notice that as per the MCD (Amended) Rules, 2021, the provision of penalties is attracted for non-compliance of the above rules.
- 03. The non-submission of FMCP under rule 24(1) of MCDR, 2017 will attract the forfeiture of financial assurance /Bank Guarantee as per the rule 24(3) of MCD (Amended) rules, 2021.
- 04. You are, therefore, directed to **show cause** within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
- 05. Please note that no further notice will be given to you in this regard.
