विषय/Subject: Violation of provisions of MCDR 2017 in respect of your Hirabuddini Gold Mine, ML 2578 over an extent of 22.18 ha(as per lease dead) in Hirabuddini Village, Manvi Taluk, Raichur District of Karnataka State.
Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 12.01.2022 by Sri Sandeep Kumar Singh, ACOM and Shri K. Srinivas, JMG in presence of Sri Kumar Mohan Singh, Mines Manager, Sri Jhonson, Mining Engineer and other mine officials:

|                                    | i) It was observed during site inspection that no exploration has been carried out<br>against the proposed surface diamond drilling of 5 boreholes with meterage of<br>1210m for the year 2020-21. Further for the year 2021-22, the surface diamond<br>drilling of 1 borehole with depth of 300 m & one trench (20mx2mx2m) are<br>proposed, against which till date no exploratory work is carried out. |
|                                    | ii) It was observed that against the total proposed development of 473 m (383 m on lode & 90 m off lode development), the development of only 216m has been carried out for the year 2020-21. Thus, there is a deviation of 55% less in the development.   |
|                                    | iii) It was observed that against the proposed ROM production of 60,000 tonnes for<br>the year 2020-21, however only 25681tonnes of production has been reported<br>as per the Annual Return for the year 2020-21. Thus, there is a deviation of<br>58% less in ROM production.  |
| 33                                 | The holder of a mining lease shall on or before the 30 <sup>th</sup> day of June every year submit a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32 along with the annual return. The surface geological plans and sections have not been submitted as per the provision of this rule.   |

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
