Sir/Madam,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 04/12/2021 by the undersigned in presence of the mine officials Shri N. Jaya Bharata Reddy, General Manager (Mines) and Shri L. Somasekhar Reddy, Manager (Mines).

Rule No.	Nature of violation
Rule 11 (1)	The following deviations have been found in the mine from the approved Modified Mining Plan vide letter no. 659(218)/LST/97NLR Hyderabad dated 24/05/2019 for the period of F.Y. 2019-20 to 2023-24: Exploration: During F.Y. 2019-20; it was proposed to drill 25 nos. of boreholes with cumulative depth of 830.0 meters, whereas, 08 nos. of borehole with cumulative depth of 188.50 meters have been drilled so far.

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are therefore directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.

05. Please note that no further notice will be give to you in this regard.


