**Sub. :** Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Devannagounder Limestone Mine over an area of 21.66.5 ha, Devannagounder Village, sankari-Taluk, SALEM - District.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 18/01/18 by Shri T. Phalthurai Rajhen, Asst. Mining Geologist along with Shri.K.Panneer selvam of lessee .

Rule No.	Nature of violation observed in detail
11(4)	The holder of mining lease shall submit the mining plan to the competent Authority for review atleast one hundred and eight days before the expiry of Five years period for which it was approved on the last occasion for mining Operation for a period of five subsequent years. Till date you have not submitted to this office.
27(2)	A Financial assurance shall be furnished by the holder of the mining lease for due and proper implementation of the progressive mine closure plan contained in the mining plan or the final mine closure plan, as the case may be , which shall be an amount of three lakh rupees for category A mines, and two lakh rupees for category B mines , per hectare of mining lease area put to use for mining and allied activities.Provided that the minimum amount of financial assurance to be furnished under sub-rule (1) shall be ten lakh rupees for category' A' mines and five lakh rupees for Cetaryory <b>B mines</b>

You have submitted bank guarantee for category B mines an amount of Rs 1,15,890/( Rupees one lakh fifteen thousands eighty hundreds ninety only) valid up to 05/04/2018..Consequent to notification of MCDR-2017 .you are required to submit the balance amount of Rs3,84,110/ (rupees three lakhs eighty four thousands one hundred ten only).within a period of 90 days from the date of notification of these rules. But till date you have not submitted the same.

28(1) subject to the provisions of section 4A holder of a mining lease. shall send to the authorised officer , as the case may be , and the state Government a notice in Form E ,when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. .

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
