27(2)	The holder of mining lease where financial assurance has already been furnished before commencement of these rules, an amount equal to the difference between the financial assurance due as on the date of notification of MCDR 2017 and the financial assurance already furnished, shall be furnished to the authorized officer as the case may be, with in a period of ninety days from the date of notification of these rules.
	You have submitted bank guarantee for category "B" mines an amount of Rs.20595/-(Rupees Twenty thousand and five hundred ninety five only) valid up to 31/03/2018. Consequent, to notification of MCDR- 2017. you are required to submit the balance amount of Rs. 4,79,405/- (four Lakhs seventy nine thousand four hundred and five only).which is not submitted for you rmine.
55(1)(C) (ii)	A part time mining engineer and mining geologist should be employed in the case of category B mines under these rule. No part time mining engineer and mining geologist have been employed in your mine.
