27(2)

A Financial assurance shall be furnished by the holder of the mining lease for due and proper implementation of the progressive mine closure plan contained in the mining plan or the final mine closure plan, as the case may be , which shall be an amount of three lakh rupees for category A mines, and two lakh rupees for category B mines , per hectare of mining lease area put to use for mining and allied activities. provided that minimum amount of financial assurance to be furnished under sub –rule (1), shall be ten lakh rupees for Category "A" mines and five lakh rupees for Category "B" mines

You have submitted bank guarantee for category B mines an amount of 100000/(Rupees one lakh only) valid up to 10/03/2021..Consequent to notification of MCDR-2017 .you are required to submit the balance amount of Rs400000/ (four lakh rupees only).within a period of 90days from the date of notification ,of these rules. But, till date you have not submitted the same.

28(1). Subject to the provisions of section 4A, the holder of a mining lease shall send to the authorized officer, as the case may be , and the state Government a notice in Form E when the mining or mineral processing operations in the mine or part thereof are discontinued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. You are advised to rectify the above violation s immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
