You are, therefore, hereby directed to **show-cause** within a period of 30(thirty) days from the date of issue of this letter, as to why you should not be **prosecuted** for the above offence and or mining operations suspended under the provision of Rules 13(2) of MCDR,1988 in the mine till the compliance of the aforesaid violation.
- 04. Please note that **no further notice** will be given to you in this regard. .
