Sub: Violation of provisions of MCDR, 1988 in respect of Garbham Manganese Mine over an extent of 264.54 ha in Garbham Village & Mandal, Vizianagaram dist., A.P.

Sir,

The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during inspection on 25.1.2017 by Smt. Ch.Suseela, Assistant Mining Geologist., IBM accompanied by Sri. G.V.Subba Rao, Agent and Sri.P. Ramakrishna, Geologist.

Rule no.	Rule position	Nature of violation
13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the approved mining plan with such conditions as may have been prescribed under sub-rule (2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining plan or scheme approved under rule 11 or 12 as the case may be.	The mining operations were not carried out in accordance with the approved Scheme of Mining vide this office letter No. AP/VZNR/MS/MN-265/SZ dated 2.12.2013 for the period 2013-14 to 2017-18 to the extent indicated below: (i)Against the proposal of drilling 10 bore holes during the year 2015-16, no drilling has been carried out.(Ref 3.3.3 of the approved document)

02. It is again brought to your notice that non compliance of the provisions of Rule 13(1) leads to order of suspension of mining operations and these violations also constitutes an offence punishable under Rule-58 of MCDR, 1988.
03. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under rule 13(2) of MCDR,1988.
04. Please note that no further notice will be given to you in this regard.
