Subject: Violation of provisions of MCDR, 1988 in respect of your Siddeswari Devi padmavathi Manganese Mine over an extent of 19.78 ha in Itikarlapalli & Pedanadipalli Villages, Cheepurupalli Mandal, Vizianagaram district, Andhra Pradesh State .

Sir,

The following provisions of Mineral Conservation and Development Rules 1988, were found violated in your above mine during inspection on 24.1.2017 by Smt. Ch.Suseela, Assistant Mining Geologist., IBM accompanied by Yourself and Shri. B.Dasaradha Rao, Agent.

Rule no.	Rule position	Nature of violation
13(1)	Every holder of a mining lease shall carry out mining operations in accordance with the approved mining plan with such conditions as may have been prescribed under sub-rule (2) of rule 9 or with such modifications, if any, as permitted under rule 10 or the mining plan or scheme approved under rule 11 or 12 as the case may be.	The validity of proposals in the approved Mining plan approved vide this office letter dated 21.1.2009 has been expired on 31.03.2013. Since you have no approved proposals in the form of Mining Plan/ Scheme of Mining for your above mentioned Mine for the subsequent period, it is evident that the Mining Operations are not being carried out in accordance with the approved document.

02. It is again brought to your notice that non compliance of the provisions of Rule 13(1) leads to order of suspension of mining operations and this violation also constitutes an offence punishable under Rule-58 of MCDR, 1988.
03. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or the mining operations should not be suspended under rule 13(2) of MCDR,1988.
04. Please note that no further notice will be given to you in this regard.
